Methods of Giving:

Payroll Deduction

Donations are automatically deducted from your payroll check in 10 monthly installments.

Credit Card Option

You may make a one time donation via credit card or you may choose a monthly, quarterly, or semi-annual credit card option.

Endowment Funds

The principal of Endowment Funds is not spent. The Foundation policy is to distribute 3- 6% (determined by the Investment Committee each year – based on fund performances) of the market value each year to be used for the purpose of the fund. Endowment funds have been established for scholarships, programs, facilities, divisions, departments and special events at Glendale Community College.

Current Endowment Funds

Faculty, staff, alumni and friends of the College have established more than 300 endowment funds. These funds can be added to by anyone who wishes to support their purpose. For a list of funds, call the Foundation office (ext. 5199) or stop by AD 149.

Establishing your own named fund

An endowment fund can be established for \$2500. To assist first time donors, the Foundation will provide \$1250 of the required \$2500.
