## WHAT'S A BOG?

A BOG\* is a waiver of enrollment fees provided by the State of California for students who have been California residents for more than one year. *Students who are required to pay non-resident tuition do not qualify. Effective Fall 2016 students will have to meet GCC Academic Progress standards to be eligible for a BOG Fee Waiver.*

### PLAN AHEAD!

Do not wait until you want to register to apply. Students may be dropped for non-payment of fees. If you have already filed your 2016-2017 FAFSA or 2016-2017 CA Dream Application (for AB540 students) you may not need to complete this form. Check your financial aid records on MyGCC to determine if you have already been awarded a BOG and do not need to submit this form.

### WHAT HAPPENS IF I RECEIVE A BOG?

If you are eligible for a BOG A, B, or C your enrollment fees are waived, regardless of how many classes you enroll in. All other fees charged (i.e. health, student services, parking, technology, and ID card fees) remain your responsibility to pay. If you have already paid your enrollment fees and qualify for a BOG, you will receive a refund of the enrollment fees. Refund checks are automatically calculated and mailed by the Tuition Office.

**The attached application is for the Summer 2016, Fall 2016, Winter 2017 and Spring 2017 semesters. You only need to apply once per year.**

There are three ways to qualify for a BOG. You only need to be eligible for one.

**\*\* METHOD A:** Provide documentation of TANF/Cal Works, SSI, or General Relief benefits you receive. If you are considered dependent, you must provide proof of the benefits your parents are receiving. Acceptable documentation includes:

- \* Copy of current or prior month's benefit check **or**
- \* Current or prior month's bank statement showing direct deposit of TANF/Cal Works, GR or SSI funds **or**
- \* Current or prior month's eligibility letter **or**
- \* GCC Untaxed Income Verification Form completed by the agency **or**
- \* Other official agency verification

**Only Method A recipients receive discounted health fees and parking rates.**

**\*\* METHOD B:** Provide income and household size information by completing the Method B Enrollment Fee Waiver section of the BOG application. All income information must be complete and accurate. You may be asked to provide tax returns or other verifying documents.

**METHOD C:** If you don't qualify for Method A or B, you may qualify for a BOG under Method C by completing the 2016-2017 FAFSA or 2016-2017 CA Dream Application (for AB540 students) and listing GCC (001203) as one of the colleges you want to receive your information.

\* The official name for BOG is BOGEFW (Board of Governors Enrollment Fee Waiver).

\*\* Students who receive BOG A or BOG B may qualify for EOPS. Contact the EOPS Office regarding eligibility.

## IMPLEMENTATION OF Assembly Bill 1899: Victims of Trafficking, Domestic Violence and other Serious Crimes

AB 1899, chaptered in September of 2012, provides for a non-resident enrollment fee exemption for "Victims of trafficking, domestic violence and other serious crimes". In addition, the legislation allows these students to apply for and, if eligible, receive financial aid from programs administered by public postsecondary institutions or the state of California. Finally, the legislation provides that enrollment fees shall be waived for these students who apply for and are eligible to receive Board of Governor enrollment fee waivers.

This **FEE WAIVER** application is for California residents, eligible AB540 students, and eligible AB1899 students, as determined by the Admissions or Registrar's Office. If you have not had your California residency or eligibility status determined by the Admissions or the Registrar, please see one of those offices to obtain the valid determination. Fee waiver eligibility cannot be determined until your status has been verified.

## IMPLEMENTATION OF THE CALIFORNIA DOMESTIC PARTNER RIGHTS AND RESPONSIBILITIES ACT

The California Domestic Partner Rights and Responsibilities Act extends rights, benefits, responsibilities and obligations to individuals in domestic partnerships registered with the California Secretary of State under Section 297 of the Family Code. If **you** are in a Registered Domestic Partnership (RDP), or legal same sex marriage, you will be treated as an Independent married student to determine eligibility for this Enrollment Fee Waiver and will need to provide income and household information for your domestic partner. If you are a dependent student and your parent is in a Registered Domestic Partnership, or legal same sex marriage, you will be treated the same as a student with married parents and income and household information will be required for the parent's domestic partner.

**Note: These provisions apply to state student financial aid ONLY, and not to federal student financial aid.**
