> Mr. Miller said that he was speaking on behalf of his daughter, Morgan Heather Miller, a GCC student, and also on behalf of persons he represents in the Guild, CSEA, students and Dr. Gregory Ross, who is present. Said that he wished to address two areas:

- 1. Said that he was addressing a comment made by the Board President at the January board meeting regarding community participation. Mr. Miller said that the lack of community participation goes to the agenda item regarding the compliance of the Brown Act. Said that there is technical compliance and substantive compliance.
