Liability Insurance Requirement

Organizations requesting permits for use of any campus facility must provide evidence of liability insurance covering their activities while using college facilities. The District shall be named as additional insured on a Certificate of Insurance provided to the College District, **two weeks prior to the event or as agreed**, by a licensed insurance carrier. Liability coverage on that policy shall not be less than \$1,000,000. To meet this insurance requirement, the Permittee may purchase insurance on-line through the TULIP Program (www.onebeaconentertainment.com/) offered by our insurance brokers.
